FUNERAL ATTENDANCE RECORD



Why is this information being collected?

To comply with the NSW Public Health Orders, any person attending a funeral service must provide their name and phone number. This information will be retained by Northern Cemeteries and may be provided to the NSW Chief Health Officer at their request to assist with 'contact tracing'. This record will be securely destroyed when authorised by NSW health authorities.

Information for Funeral Directors:

- Before the service commences, please collect the above information from all mourners in attendance
- The completed form must be provided to Northern Cemeteries staff before the service can commence.

Who can attend funeral services?

To attend a funeral service at Northern Cemeteries, a person must answer NO to the following questions:

1. Have you entered NSW from Victoria or overseas in the last 14 days, or have been in a NSW Hotspot? (If yes, you must have completed 14 days of self-isolation).
2. In the past 14 days, have you had or are you aware of any close contact with someone who has been diagnosed with or suspected of having COVID-19?
3. Do you have any reason to suspect that you have or may have COVID-19?

If the person answers YES to any of these questions they are not permitted to attend the service.

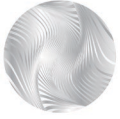
